No Although we agree with the intention behind this new standard, we are concerned that some of the new proposals will impact donor experience and donations, in particular, point 3.3.11 which requires consumer consent to be established every 12 months. Our members are very concerned about the negative impact this will have on the income from regular donations via text and donor experience. We appreciate that this decision was not taken lightly and is based on research with Jigsaw Research that found consumers are open to additional steps when signing-up to subscription services ¹ and guidance from the Competition & Markets Authority. Nevertheless, |
| | we feel that neither of these pieces of research account for differences between donating to a cause and paying for a service. Between 2019-2020, only 35 charities reported 130 complaints regarding SMS donations to the fundraising regulator, which has decreased by 22% from last year ² . What's more, the complaints were not related to signing up in error or donors misunderstanding what they were signing up to, showing us that whilst that is a concern for consumers, this is not the case for donors. Equally, the CMA's guidance is designed to protect consumers from the loyalty penalty, as supporters are not paying for a service, this is not applicable to charity donations. |
| | In addition, other regular payment mechanisms such as direct debits, or subscription services for newspapers or streaming do not require consent to be provided every 12 months – even though these will be likely to be of higher value payments compared to text giving. We question the need to introduce a need to establish consent every 12 months for this service when it is not part of the normal experience of consumers who use a range of regular payments methods in their day to day lives. |
| | We believe there are a number of alternatives that could help protect donors without negatively impacting |

Members feel the current requirement to remind donors on a monthly basis that a donation will be made, which includes options to stop and skip, is sufficient to allow them to opt-out. Should you feel there is still a need for an additional confirmation every 12 months, we recommend adopting a similar 'opt-out' method that mirrors these monthly reminders as this will keep the messaging to donors consistent. |

| | Having consulted with our members, we are concerned that should you choose to move forward with this proposal, charities will no longer see regular giving via text as a viable source of income, meaning some will reduce their investment in these areas whilst others will not adopt it altogether. This would be a disappointing outcome for both fundraisers and the PSA and we urge you to consider our suggested alternatives. |

No We agree with the new standard and believe that it will improve public trust in both the commercial and non-profit sectors. However, returning donations is regulated by the Charity Commission and therefore overlaps with points 3.4.12-3.4.16 regarding refunds. Given supporters are donating relatively low amounts, between £5-£10, we do not see your requirements clashing with current guidelines; we simply ask that you include a provision that states returning donations must be in-line with the Charity Commission's processes to avoid confusion. |

No We understand why a comprehensive registration process in this area is necessary for the private sector, given the fast-growing number of organisations in this space. Regarding charity registrations, we request that you include charities in point 3.8.9 as one of the categories exempt from registration and from re-registering every 12 months. Charities already go through a rigorous registration process by the Charity Commission which includes giving detailed information on governance and finances, we therefore feel that if an organisation has a valid charity number, this should be sufficient proof that they are meeting your organisational standards. |

No Although our members support improved compliance and monitoring in this area and believe that is will protect donors and consumers, they have raised with us that they are unclear on their responsibilities. Smaller charities in particular often do not have compliance teams, meaning due diligence can be timely and costly. Although they are keen to be compliant, they want to do efficiently, we therefore ask that you provide clarification on the responsibilities of the charities and the responsibilities of their service providers. | |
